No.FTX.56/2017/Pt-I/200.- In exercise of the powers conferred by sub-sections (1) of section 11 of the Assam Goods and Services Tax Act, 2017 (Assam Act No. XXVIII of 2017), the Governor of Assam, on the recommendations of the Council, hereby makes the following further amendments in the Government of Assam, Finance (Taxation) Department, notification No. FTX.56/2017/15 dated the 29th June, 2017, published in the Assam Gazette, Extraordinary, vide number 336 dated the 29th June, 2017, namely:-

In the said notification, in the Schedule, -

(i) for Sl. No. 43A and the entries relating thereto, the following serial numbers with entries relating thereto shall be substituted and thereafter a new serial number with entries relating thereto shall be inserted, namely: -
