Dated Dispur, the 08th July, 2026

No: CT/COMP-6/2024/107: In pursuance of the initiatives of the Government of Assam for improving the Ease of Doing Business (EoDB) ecosystem in the State through digitized and online delivery of Government services, it has been decided to establish a single-window facility, namely, the **"GST Service/Facilitation Centre for Taxpayers/DDOs"** in every Unit Office under the administrative control of this Department.

The Service/Facilitation Centre shall function under the control and supervision of the jurisdictional Nodal Officer nominated for the purpose, as specified in **Annexure-I**. Each jurisdictional Nodal Officer shall be assisted by one assistant designated as the **Facilitating Assistant** to provide guidance, assistance and support services to taxpayers and DDOs in matters relating to GST compliance. Service/Facilitation Center shall also be responsible for receiving grievances and resolving the same through the State single window system. All jurisdictional Nodal Officers shall report to State Nodal Officer who shall be responsible for supervision, monitoring and effective functioning of the Service/Facilitation Centre at State level.

The jurisdictional Nodal Officers are directed to make a separate corner with an eye catching banner to lead the people to the Service/Facilitation Center and to render quality service in an effective manner. The Nodal Officers are also required to give wide publicity of this effect encompassing their jurisdiction to facilitate optimum benefits of the Service/Facilitation Center.

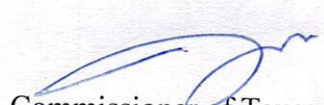
