## NOTIFICATION

The 17th February, 2024

eCF No. 405282/15.- In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Taxation Service Rules, 1995, hereinafter referred to as the principal Rules, in the manner hereinafter appearing, namely: —

Short title and commencement 1. (1) These rules may be called the Assam Taxation Service (Amendment) Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 12 2. In the principal Rules, in rule 12,

(i) for sub-rule (6), the following shall be substituted, namely :-

“(6) The Appointing Authority on receipt of lists recommended by the Committee shall consider the list prepared for promotion cadre wise along with A.C.R. and personal files of the employees and approve the list unless it considers any change or modification necessary. If the Appointing Authority considers it necessary to make any change in the list received from the Committee, he shall inform the Committee

of the changes proposed and after taking into account the comments, if any, of the Committee, may approve the list finally with such modification, if any, as in his opinion, be just and proper.”;

(ii) for sub-rule (7), the following shall be substituted, namely :-

“ (7) The list so approved by the Appointing Authority shall form the Select list for the purpose of appointment by promotion.”.

(iii) in sub-rule (9), the words “by the Commission”, appearing in between the words “approved” and “shall be ” shall be deleted.

(iv) in sub-rule (11), in second line for the word “Commission”, appearing at the end, the words “Appointing Authority” shall be substituted.

Amendment of rule 20 3. In the principal Rules, in rule 20, for sub-rule (1), the following shall be substituted, namely, -

“(1) (a) The Seniority of a member in a cadre appointed by direct recruitment shall be determined in accordance with the order of preference in the list recommended by the Commission under rule 6 and joins the appointment within 15 days from the date of receipt of the order or within the extended period as mentioned in rule 17.

(b) The Seniority of a member in a cadre appointed by promotion shall be determined in accordance with the order of preference in the list approved by the Appointing Authority and joins the appointment within 15 days from the date of receipt of the order or within the extended period as mentioned in rule 17.”
