NOTIFICATION

The 25th June, 2012

No.FTX.90/2004/Pt-II/61.-In exercise of the powers conferred by sub-sections (3), (4) and (5) of Section 13 of the Central Sales Tax Act, 1956 (Central Act 74 of 1956), the Governor of Assam is hereby pleased to make the following rules further to amend the Central Sales Tax (Assam) Rules, 1957, hereinafter referred to as the principal Rules, namely:-

Short title and commencement.

- (1) These rules may be called the Central Sales Tax (Assam) (Amendment) Rules, 2012.
- (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of rule 8

- In the principal Rules, in rule 8, in sub-rule (1), the word "blank" appearing between the letter "a" and the words "declaration form "C"" shall be omitted.

Amendment of rule 8-E

- In the principal Rules, in rule 8-E, in sub-rule (1), the word "blank" appearing between the letter "a" and the words "declaration in Form 'F'" shall be omitted.

Amendment of rule 8-F

- In the principal Rules, in rule 8-F, for the existing sub-rule (1), the following shall be substituted, namely:—

“(1) A dealer who wants to obtain from the Superintendent of Taxes Form ‘C’, ‘F’ or ‘H’ shall apply to the Superintendent of Taxes for such form in Form No. IA. The application shall be accompanied by proof of payment of the following fee:-

- Rs. 2.00 per form; or
- Rs. 32.00 per book of 25 forms; or
- Rs. 127.00 per book of 100 forms.

An application which is not accompanied by proof of payment of the fee shall be rejected. The fee shall be paid into a Government Treasury.”

5. In the principal Rules, after Form-I, a new Form-IA shall be inserted, namely: —
