**No. CT/GST-12/2017/120.-** In pursuant to Government Notification No. FTX.79/2017/74 dated 18<sup>th</sup> December-2020 on re-designation of cadres and in exercise of the powers conferred by sub-section (2) of section 4 of the Assam Goods and Services Tax Act, 2017 (Assam Act No. XXVIII of 2017), the Principal Commissioner of State tax, Assam hereby orders that the following classes of officers shall exercise the powers conferred upon them in their territorial jurisdiction specified in column (4) of the Table given below:-
