**NOTIFICATION No. 13/2021-STATE TAX (RATE)**

The 18th January, 2022

**No.FTX.56/2017/Pt-III/559.-** In exercise of the powers conferred by sub-section (1) of section 9 and sub-section (5) of section 15 of the Assam Goods and Services Tax Act, 2017 (Assam Act No. XXVIII of 2017), the Governor of Assam, on the recommendations of the Council, is hereby pleased to make the following further amendments in the notification of the Finance (Taxation) Department, Government of Assam Notification No. FTX.56/2017/14 dated the 29<sup>th</sup> June, 2017 (Notification No. 1/2017-State Tax Rate), published in the Assam Gazette, Extraordinary, vide number 335, dated the 29<sup>th</sup> June, 2017, namely :-

In the said notification,-

- in Schedule II - 6%, S.No.243 and the entries relating thereto shall be omitted;
- in Schedule III – 9%, against S.No. 452P, in the entry in column (3), the words “in respect of Information Technology software” shall be omitted.

This notification shall be deemed to have come into force with effect from the 27<sup>th</sup> day of October, 2021.
