NOTIFICATION

No. FTX.25/2009/19: In exercise of the powers conferred by sub-section (3) of section 6 of the Assam Entry Tax Act, 2008 (Assam Act XII of 2008) and in super-session of earlier Notification No. FTX.58/2008/48 dated 16.10.2008 published vide Assam Gazette Extra-Ordinary No.294 dated 16.10.2008, the Governor of Assam, having considered it necessary in the public interest so to do, hereby exempts fully/partially, as the case may be, exempts the importer shown in column (1) of the Table below from the liability to pay entry tax in respect of specified goods mentioned in column (2), when imported into a local area for use, subject to the restrictions and conditions specified in column (3) of the said table:-
