## NOTIFICATION

The 16<sup>th</sup> October, 2008.

**No. FTX.76/2006/14:** Whereas the draft of certain rules further to amend the Assam Professions, Trades, Callings and Employments Taxation Rules, 1947, hereinafter referred to as the principal Rules which the Governor of Assam proposes to make in exercise of the powers conferred by Section 19 of the Assam Professions, Trades, Callings and Employments Taxation Act, 1947 (Assam Act VI of 1947), was published as required under section 19 of the said Act in the Assam Gazette, Extra-ordinary No. 22 dated 04.02.2008 under Notification of the Government of Assam inviting objections and suggestions from all persons likely to be affected before expiry of a period of thirty days from the date of publication of the said Notification in the Official Gazette.

And whereas no objection or suggestions was received from the public on the said draft.

Now, therefore, in exercise of powers conferred by section 19 of the said Act, the Governor of Assam hereby makes the following rules, namely:-
