GOVERNMENT OF ASSAM ORDERS BY THE GOVERNOR FINANCE (TAXATION) DEPARTMENT

NOTIFICATION

The 2nd June, 2015

No. FTX.29/2003/Pt.-I/25.- Whereas the Government is going to introduce on-line issuance of statutory Forms within a short time; and whereas necessary amendment in the Rules is required to be made urgently before on-line issuance of the said Forms. Therefore the Government is satisfied that the circumstances exist which render it necessary for it to amend the Assam Value Added Tax Rules, 2005, hereinafter referred to as the principal Rules, immediately without previous publication of such rules as authorised under the proviso to-sub-section (1) of section 106 of the Assam Value Added Tax Act, 2003 (Assam Act-VIII of 2005);

Now, therefore, in exercise of the powers conferred by sub-section(1) of section 106 of the Assam Value Added Tax Act, 2003 (Assam Act VIII of 2005), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam Value Added Tax Rules, 2005, namely:-

Short title and commencement.

- 1. (1) These rules may be called the Assam Value Added Tax (Amendment) Rules, 2015.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of Form 13

- 2. In the principal Rules, in Form-13,
 - (i) the words and brackets "(Dealer shall submit particulars in Part-G to Part-N quarterly covering transactions made during the quarter)" appearing after Part-FF shall be omitted.
 - (ii) for the existing Part-G, Part-GG, Part-H, Part-I, Part-K, Part-L, Part-M and Part-N, the following shall be substituted, namely:
